The Board met this 4th day of March 2025 to consider the annexation petition of Richard Spoor, agent to annex 58.9661 acres to the Village of Maineville pursuant to Ohio Revised Code Section 709.23 (Expedited Type 2).

Bruce McGary, Assistant Prosecutor, stated that he had reviewed the file and that the annexation meets the criteria needed for approval and that no objection had been received from the Hamilton Township.




